Zero Gravity Float Spa (located in central in Altrincham, opposite the interchange) offers ultimate relaxation with our Floatation Therapy and Massage Services. We have four spacious float tanks filled with Epsom salt water, providing the ultimate sensory deprivation experience for your mind and body. Our skilled therapists also provide a range of massages, including Swedish and deep tissue, to help you unwind and improve your well-being. Chris has been with Zero Gravity as it's Technical Director since the company first opened in July 2018, having initially turned to float therapy to relieve his back pain. As he started floating regularly, he noticed the tranquillity he achieved during his sessions carried over into his everyday life!



1. How has business been since Covid?

Our business was hugely affected by Covid both by the disruptions caused by the lockdowns, but also for a long time afterwards as people were still apprehensive about being in public settings we estimate that it knocked our business back by around 2 years, and it only felt back to normal by around the end of 2021. We're extremely grateful to have survived Covid, and in one way there was aa silver lining for us - during lockdowns there was an increased discussion surrounding mental health and mindfulness, which lead to many people discovering floating during this time.

2. What keeps you awake at night?

Not much keeps me awake at night - mainly because I float so often!

3. How did you get into your business?

My business partner Simon actually got me into floating, and he was the one with the idea to set up our own float centre. He used to float regularly in another centre in Ancoats, as he finds floating really helps with his sleep, but the other centre was becoming booked up really far in advance, so Simon couldn't get the times he wanted. Also, although we both enjoyed the floats themselves at the other centre, we always felt that there were many areas that could be improved on such as adding a massage side to the business, so it made sense to start up Zero Gravity!

4. What is your USP?

Our USP is that we give equal importance to our floats as to our massages - the two sessions complement each other perfectly! Most other float centres we've looked at only offer floats, and the few that *do* offer massage seem to do so as an afterthought.



One thing I would like chamber members to do is to make sure you're taking the time off working to look after yourself and reset! Sometimes it can feel like we always have to go at a hundred miles an hour, but if you push yourself that hard you'll simply end up burning out! If you can take some time doing something relaxing that you enjoy, whether it be cycling, reading a book in the garden, or even coming in with us to have a float or massage, you'll feel a lot more relaxed and will be able to more fully apply yourself when you are working. Other than that, we always appreciate when people spread the word about floating specifically - it's so unusual people are more likely to try it if someone they know recommends it!

6. You're off to the Desert Island, who is with you and what 3 things would you take – and why?

On the desert island, I'd like to take Simon, his girlfriend and a few of my other oldest friends. Then the three things I'd like to take: an unlimited supply of chilled beer, something to play some music with and a barbeque - then we can have a never-ending beach party!

Altrincham Awarded Prestigious Purple Flag Accreditation for its Vibrant Night-time Economy

Greater Manchester Clean Air Scheme - Financial Support for HGV's



Greater Manchester's ten local authorities remain under a legal direction to comply with legal nitrogen dioxide (NO₂) limits in the shortest time possible and by 2026 at the latest. In February 2023, Government wrote to GM to ask for additional evidence to enable them to further consider the case for GM's non-charging approach, including benchmarking GM's proposals against a charging zone model for central Manchester and Salford. GM was due to submit this further evidence in June 2023.

However, part of the modelling included the emissions benefits of what is known as a bus 'retrofit' programme, which has now been put under review by government. The review is in light of their early research, which has revealed that retrofitting has delivered 'variable' results in reducing emissions.

Due to the bus retrofit review, there is now further work to undertake to understand how this will affect our Clean Air Plan. The government has given GM and other authorities revised guidance for air quality modelling, which we need to include in our work before submitting further evidence to government. GM leaders have written to the Environment Secretary to request that modelling for the Clean Air Plan takes into account government's bus retrofit review study findings, due to conclude in autumn 2023.

In the meantime GM has secured £120m of government funding to help eligible owners of vehicles which would be non-compliant in a Clean Air Zone upgrade to compliant vehicles. Government has said this funding will continue to be available for the new Clean Air Plan. Of this, GM has £7.6m to help eligible businesses, organisations and people who own HGVs switch to cleaner vehicles which meet the Clean Air Zone emission standards (referred to as compliant vehicles). This is available now.

Financial support will be available as a lump sum grant, contribution towards vehicle finance, or a combination of the two. Funding will not be available to replace or retrofit all non-compliant vehicles. It will initially be targeted to support micro-businesses, self-employed people, sole-traders, charities, social enterprises and eligible private owners/registered keepers of a non-compliant vehicle. **A second round of funding is now open to eligible small businesses**.

Workplace Charging Scheme - EV Charging Points Government Grants The Workplace Charging Scheme (WCS) is a voucher-based scheme that provides



eligible businesses with support towards the upfront costs of the purchase and installation of electric vehicle (EV) charge points.

The WCS is open to businesses, charities and public sector organisations that meet the applicant and site eligibility criteria.

The grant covers up to 75% of the total costs of the purchase and installation of EV charge points (inclusive of VAT), capped at a maximum of:

- £350 per socket
- 40 sockets across all sites per applicant for instance, if you would like to install them in 40 sites, you will have 1 socket available per site

After applying using the online application form, successful applicants are issued with a unique identification voucher code by email, which can then be given to any Office for Zero Emission Vehicles (OZEV) authorised WCS installer. For further information, click <u>here</u>.

Supported Internships Work Programme

Supported Internships are a work-based study programme for 16-24 year old young people with Special Educational Needs and Disabilities. They offer the opportunity for young people to experience real work placements with the aim to progress into sustainable, paid employment.

We are in the process of setting up a supported internship within Trafford Council. You would receive full support from Trafford Council as well as the education provider (Trafford College) and the supported internship scheme provider (Pure Innovations).

Supported interns can offer a huge benefit to your organisation. Supported by their job coach, their role within your organisation will be designed to suit the needs of the business as well as the needs of the intern. Furthermore, supported interns are classed as being in full-time education, which is fully funded, therefore hosting an intern is at no additional cost to your organisation.

Public Consultation - Closure of Rail Ticket Offices

The Rail Industry and Government have announced proposals to close rail station ticket offices or reduce their operating hours. The changes would come into effect over an 18-month period with ticket offices at stations in Hale, Chassen Road, Urmston and Flixton affected.

Transport for Greater Manchester and Greater Manchester Combined Authority will be raising significant concerns with the plans through the formal consultation process which has been launched. Residents and businesses are invited to participate in the consultation which ends on **Friday 1st September 2023**.

EOIs invited for the Community Automated Defibrillators Fund

The Department of Health and Social Care is inviting interested organisations to register expressions of interest for its £1 million Community Automated External Defibrillators Fund, aimed at increasing the number of AEDs in public places where they are most needed and help save lives.

An estimated 1,000 new defibrillators are to be provided by the fund, with the potential for this to double as successful applicants will be asked to match the funding they receive partially or fully.

As part of the grant award, applicants will be asked to demonstrate that defibrillators will be placed in areas where they are most needed, such as places with high footfall, vulnerable people, rural areas or due to the nature of activity at the site.

Examples could include town halls, community centres, local shops, post offices and local parks, to ensure that defibrillators are evenly spread throughout communities and easily accessible if someone is experiencing an unexpected cardiac arrest.



To accelerate the administration of the grant in advance of the partner being chosen, prospective organisations who wish to obtain funding for a defibrillator are now invited to register an expression of interest with the Department of Health and Social Care. Organisations who submit an expression of interest will be notified once grant applications open to the Department of Health and Social Care's £1 million Community AED Fund.


