Welcome to the October Newsletter

The Chancellor's 'mini-budget' kicked off a week of economic turbulence, impacting mortgage markets directly. Many businesses are now worried about rising costs and how to survive this next blow to our economic recovery after the brief recovery time we enjoyed post covid/lockdown.

Mr Kwarteng's 'mini-budget' was flawed, but it didn't drive the Pound to new lows and cause the Bank of England to step in to save government bonds on its own. The Government took the unusual move of not allowing the Office for Budget Responsibility (OBR), or any alternative regulatory body, to forecast their economic plans pre-announcement. This simple act fuelled uncertainty in the financial markets before the 'mini-budget' had even been made public.

The Chamber is working with Trafford and the Growth Company to support our members and Ian Whilby (Growth Company) will be presenting the local initiatives on how we can have access to this support at the November breakfast.

## FIRST FOR BUSINESS

### **Government support to help cut energy costs for businesses;**

Earlier this week, the UK Government announced plans to help cut energy costs for businesses.

Through a new government Energy Bill Relief Scheme, the government will provide a discount on wholesale gas and electricity prices for all non-domestic customers (including all UK businesses and the voluntary sector) whose current gas and electricity prices have been significantly inflated in light of global energy prices. This support will be equivalent to the Energy Price Guarantee put in place for households.

It will apply to fixed contracts agreed on or after 1 April 2022, as well as to deemed, variable and flexible tariffs and contracts. It will apply to energy usage from 1 October 2022 to 31 March 2023, running for an initial 6 month period for all non-domestic energy users. The savings will be first seen in October bills, which are typically received in November.

As with the Energy Price Guarantee for households, customers do not need to take action or apply to the scheme to access the support. Support (in the form of a p/kWh discount) will automatically be applied to bills.

## Gtr Manchester Clean Air Plan Survey

Greater Manchester (GM) local authorities are undertaking a participatory policy development process to develop and shape the new Clean Air Plan Policy, including proposals for funding support.

The case for a new plan, which has been submitted to Government, sets out evidence supporting an investment-led approach, with no charging Clean Air Zone, to address the city-region's nitrogen dioxide air pollution problem. This is to ensure the right funding and eligibility criteria are in place to enable category B vehicles, which includes buses, coaches, taxis, PHVs and HGVs, to be upgraded to those with cleaner engines, while mitigating any additional economic risk or hardship to residents and businesses.

### Impacted vehicle owner survey

To ensure the development of the new policy is well-grounded in evidence, GM wants the input of key stakeholders, including [HGV/Coach/Taxi/PHV] owners. This is to ensure the right funding and eligibility criteria are in place to enable category B vehicles to be upgraded to those with cleaner engines, while mitigating any additional economic risk or hardship to residents and businesses.

If you are a HGV or a coach owner operating in or through Greater Manchester and want to help shape the new clean air plan proposals, GM wants to hear from you. Online surveys are now open until **10 October 2022**. The survey will take around 15 minutes and is available [here](#).

A public consultation on the Clean Air Plan proposals will take place in early 2023, subject to government feedback.
