Market News

- Pound open to losses in absence of data Russia-Ukraine talks help limit downside.
- Euro mixed as war negotiations begin EUR unable to fully recover sanction-induced losses.
- US Dollar slips as risk appetite improves Peace talks spark modest recovery in market mood
- Russia-Ukraine war in focus today Missile strikes continue despite ongoing negotiations.

Pound (GBP) Muted amid Lack of Data

The Pound (GBP) was subdued yesterday as a lack of UK economic data left Sterling vulnerable to losses.

Meanwhile, markets took a breather as Ukrainian and Russian diplomats met on the Ukrainian-Belarusian border to negotiate. This may have helped to limit the Pound's downside.

The Russia-Ukraine war is likely to remain foremost in investors' minds today. If both sides agree on a ceasefire, then Sterling may find some support. However, analysts believe this is unlikely.

Euro (EUR) Struggles to Regain Losses

The Euro (EUR) was mixed during yesterday's session, edging higher against the Pound and the US Dollar (USD) as Russia-Ukraine negotiations began.

However, the single currency was unable to fully regain the heavy losses it suffered when markets reopened on Sunday evening GMT. The crippling economic sanctions on Russia announced over the weekend will likely have a particularly damaging effect on the Eurozone economy.

Turning to today, Germany's latest retail sales and inflation reports could impact EUR, although investors will likely be more focused on the situation in Ukraine.

US Dollar (USD) Falls as Peace Talks Begin

The safe-haven US Dollar softened yesterday amid a cautious recovery in risk appetite.

Markets welcomed the peace talks between Ukrainian and Russian delegates. Although many think a ceasefire is unlikely, the opening of diplomatic channels is definitely a positive development in the ongoing war.

Risk appetite may continue to drive USD movement today. Later in the afternoon, the US ISM manufacturing PMI could also impact the 'Greenback'.

Canadian Dollar (CAD) Strengthens ahead of BoC Decision

The Canadian Dollar (CAD) firmed against many of its peers yesterday as markets expect the Bank of Canada (BoC) to raise interest rates at its meeting on Wednesday.

Canada's GDP data this afternoon could impact the 'Loonie'. Analysts expect growth to have picked up modestly in the fourth quarter of 2021, despite a slowdown in December.

Australian Dollar (AUD) Gains on Australian and Chinese Data

The Australian Dollar (AUD) ticked higher overnight, despite the Reserve Bank of Australia (RBA) striking a fairly dovish tone following its latest interest rate decision.

The upside came on the back of strong Australian manufacturing data and better-than-expected Chinese PMIs.

Reminder - Clean Air Financial Support Scheme now open for HGVs

Greater Manchester's Clean Air Financial Support Scheme is now open for applications from locally-registered heavy goods vehicle (HGV) owners who could be affected by the introduction of the city-region's Clean Air Zone.

The Clean Air Zone will come into effect for these vehicles on 30 May 2022. Greater Manchester has been awarded £120m of government funding to help eligible businesses, organisations and people to move to cleaner, compliant vehicles, including £7.6m for HGV owners. Owners of private cars, motorbikes and mopeds won't need to pay a daily charge to drive in the Zone.

Funding will initially be targeted to support micro-businesses, self-employed people, sole traders, charities, social enterprises, and private owners and registered keepers of a non-compliant vehicle. Subject to available funding, there will be a second round open to all eligible owners of a non-compliant vehicle, including small businesses.

Letters are being sent to Greater Manchester-registered HGV owners that would be subject to Clean Air Zone daily charges to notify them directly about exemptions and the funding support that will be on offer.

Enterprising You has supported over 1,800 self-employed business owners across Greater Manchester since last February. It will now be extended until March 2023. This programme was the first of its kind in the country when it launched just before the pandemic hit and proved a lifeline for many small business owners by helping them to adapt and grow their business or retrain.
